Overall Job Function:

Key Responsibilities

1. Documentation and reporting

- Ensure availability of necessary project data collection and reporting tools at the office.
- Guide the project staff on effective data management especially on correct and complete documentation.
- Ensure all required data summaries and project reports are accurately and timely.
- Reporting for the project through the appropriate donor reporting system available/adopted by the project.
- Participate in data collection for project monitoring, evaluation and research when required.
- Ensure all project beneficiaries are well documented.
- Ensure no duplication in reporting from the sub county level
- Ensure data safety and information confidentiality is upheld at all times.

2. Data quality audits

- Participate in routine data quality audits together with the MER Manager
- Reviewing data prior to submission to project MER Manager
- Scheduling and participating in project DQA together with the project staff
